Superfund Cleanup - Greendell road

• Bill Bromirski traveled to Trenton on April 18<sup>th</sup> and looked at records and decided what should be copied. He collaborated all the information and asked for about 80-84 copies of records. There was a lot of correspondence from the DEP and the Township. A lot of information has been gathered regarding what has been at the site. Some examples are Tepee burner with steel enclosure, 1980 original DEP inspection; drum sampling, photos of inspections being done – mostly conducted during the winter months and water was bottled from a spring in 1982. When the copies come in they will give much more detail and will be held in the town hall. After we receive the copies, Ms. Scoleri will discuss with Mayor Durling and see what is needed to be done.

Mr. Bromirski will get his expenses together and send in for reimbursement.

Nature Conservancy - White Lake Natural Resource Area

 LaRocco handed pamphlets to all members giving information regarding the lake and all that they are doing. They currently have 2 projects for the communities which are lake monitoring (and should be done by late summer early fall) and White Lake Day. White Lake Day is a small event held on Saturday, June 20<sup>th</sup> to celebrate the features of the lake. The lake is approximately 70 acres. White Lake is open to fishing and hiking but not swimming. Ms. LaRocco is inviting communities to come and join them and to participate in the celebration. The surrounding communities are Blairstown, Hardwick, Stillwater and Frelinghuysen.
